Here's what you need to know:

Types of Gifts you can leave

- A share of your estate – from 1% to 100%.
- A cash gift – any amount of your choosing.
- A specific item – jewellery, art, or personal keepsakes.

How to prepare your Will

Before writing or updating your Will, consider:

- What you own and how you'd like it distributed.
- Who you want to remember – family, friends, charities.
- Instructions for online accounts (photos, music, etc.).
- Two executors to carry out your wishes.
- Regular reviews every 5-10 years. For guidance, visit gov.uk/make-will.
